### QSL CLUB LICENSING DECISIONS

The QSL Club Licensing Committee met on Monday 15 May 2024 to consider applications from clubs for AFC Elite, QSL and Q2 Club Licences.

After reviewing the summary of submissions, the Club Licensing Committee agreed to award AFC Elite Club Licenses to 16 clubs to participate in AFC /QFA /QSL competitions, QSL Club Licenses to 15 clubs to participate in QFA/QSL Competitions and Q2 Club Licenses to 10 clubs to participate in QFA competitions only.
